

LETTER OF INDEMNITY

To Mitsui O.S.K. Lines, Ltd.

Gentlemen,

Further, to induce you to deliver the said goods and in consideration thereof, we hereby undertake and agree as follows:

- (1) To use our best efforts to locate and produce the said Bill(s) of Lading and thereupon promptly to deliver and surrender the same to you, properly endorsed; and
- (2) To pay you on demand all freight, salvage, general average and/or other charges or expenses whatsoever in respect of the said goods; and
- (3) To indemnify and hold you, the vessel, her owners, charterers, operators, master and agents harmless from all demands, claims, liabilities, actions and expenses, including legal expenses and attorneys fees, and consequences of whatever nature which may arise out of or be connected with such delivery; and
- (4) Promptly on your demand, to settle directly by us any claim or to enter our general appearance in any proceedings instituted against you or any party protected by this undertaking in respect of the said goods, whether by a holder of the said Bill(s) of Lading or otherwise and/or to provide you with sufficient funds to defend the same and to meet any proved claims.
